


The cost to defray the expense involved in the purchase of the strawberries and ice cream is **\$3.00 per person.**

**BUYER WANTS MONEY BACK  
Valley Stream Lots Worth \$400,  
NOT \$2,355, is CLAIM**

Margaret McGarigle began a suit in the Supreme Court, Manhattan, against The Valley Stream House and Home Company asking for the rescision of her contract for the purchase of lots on Rockaway Parkway, Valley Stream, made on June 30, 1913, on which she had promised to pay \$2,350. She stated that she has already paid \$1,055, but discovered on July 19 last that the lots were worth but \$400. Improvements, including a \$1,000,000 railroad station, were promised, she declared.


The summons was served on Isidor Rosenbeck, president, who has twenty days to answer the assertions in the complaint.
