

THIS AGREEMENT made this 1st day of June, 2024 by and between the Incorporated Village of Valley Stream, a municipal corporation having its principal office at 123 South Central Avenue, Valley Stream, Town of Hempstead, County of Nassau and State of New York, hereinafter called the "Village", and the FIRE DEPARTMENT OF THE INC. VILLAGE OF VALLEY STREAM, having its principal office at Rockaway Parkway, P.O., Box 38, Valley Stream, Town of Hempstead, County of Nassau and State of New York, hereinafter called the "FIRE DEPARTMENT".

WITNESSETH

WHEREAS, the Board of Trustees of the Village of Valley Stream, on a motion made by Trustee _____ seconded by Trustee _____, and unanimously carried at a Public Hearing held on May 20, 2024, has deemed it to be in the best interests of the residents and owners of property within the Incorporated limits of the Village, that the VILLAGE enter into a contract with the FIRE DEPARTMENT for the furnishing by the FIRE DEPARTMENT of the services hereinafter described; and

WHEREAS, the execution of such contract between the VILLAGE and the FIRE DEPARTMENT is authorized pursuant to Article 4, Section 4-412 of the Village Law of the State of New York.

NOW THEREFORE, in consideration of the mutual covenants herein contained, the VILLAGE hereby engages the FIRE DEPARTMENT to furnish fire protection, emergency medical service and ambulance service within the limits of the Inc. Village of Valley Stream and the fire protection districts presently protected by the FIRE DEPARTMENT, and the FIRE DEPARTMENT agrees to furnish such service upon the following terms and conditions:

FIRST: The FIRE DEPARTMENT agrees to furnish during the entire period of this Agreement, beginning the first day of June, 2024, and ending on the 31st day of May, 2025, protection against loss by fire to property located within the incorporated limits of the Village, and the Fire Protection Districts, and to protect the lives of the inhabitants of the Village and said Fire Protection Districts to the best of its ability and at all times during the term of this Agreement, to furnish all such other services as the FIRE DEPARTMENT has heretofore rendered to the residents and property owners of the Village and said Fire Protection Districts in the performance of its regular duties.

SECOND: In consideration of the furnishing of such services, the VILLAGE will pay to the FIRE DEPARTMENT the sum of \$135,000.00 for the term of this Agreement, payment of such to be made on the first day of June, 2024.

THIRD: In accordance with provisions of this Agreement, the VILLAGE hereby authorizes the FIRE DEPARTMENT to operate all VILLAGE owned fire fighting equipment in furtherance of the performance of its regular duties.
