Acceptance of the Terms and conditions of this Release and adherence /compliance with the established Inc. Village of Valley Stream Rules and Regulations are conditions of the access card approval, retention and renewal. Access cards are non-transferable between owners and may be revoked for non-compliance as may be required by the Village.

I hereby acknowledge that I am the owner of the dog(s) listed at the bottom of this document.

I voluntarily apply to participate and utilize, with my dog(s) listed below, the Village Dog Park.

I fully understand and acknowledge that unleashing my dog and being physically present at the dog park area involves risks of injury to me, any individual accompanying me, other persons, my dog(s) and other dog(s). These risks include but not limited to, risks resulting from aggressive dogs, unpredictable behavior of the dogs, lack of proper training and /or supervision of the dogs, etc.

I further understand that despite the efforts of the Village to have dog owners and others using the Dog Park comply with the rules and Regulations, there is a risk that not all dogs present in the dog park may be licensed, nor vaccinated for rabies which may result in injury to any person and/or dog at the Dog Park including myself and my dog (s).

Additional risks to me and/or my dog(s) include, but are not limited to: dog owner/fights, dog fights; dog bites; theft or unlawful capture of my dog (s); escape by my dog(s) over and under the fences; vegetation or standing water that may be unhealthy or poisonous if consumed; burrs or seeds that may become lodged in the dog's coat, feet, eyes, nose, or ears; mosquitoes; spiders; ticks; chiggers; fleas and other insects; and wildlife typically found in a park, such as raccoons; opossums; field mice etc.

If is further my understanding that usage of the Dog Park is self-directed and shall not be supervised, directly nor indirectly, by an agent, servant and /or employee of the Village. Additionally, I accept and acknowledge that I assume any and all risks associated with the usage of the dog park, including fixtures and equipment, in an unsupervised and self-directed manner.

By accepting the prescribed terms and conditions and signing this release, I do hereby agree to indemnify and same harmless the Village, its agents, officers, and employees and assigns from and against all loss, cost, damages, expense and liability resulting from my use of the dog park, including death, sickness, injury, and disease to any person or dog, or destruction to property, real or personal, arising directly from my use of the dog park, I do hereby acknowledge that I have carefully read this release of liability, and fully understand, agree with, and accept the terms and conditions that have been outlined above and in the attached literature. Further, I acknowledge that I have received and reviewed a copy of the Dog Park Rules and Regulations for the dog park's use and agree to abide by said rules as set forth.

I accept and acknowledge personal responsibility and liability for any injury or damage caused as a result of the behavior of my dog, whether the loss occurs as a result of biting, jumping, scratching, digging, charging or any other behavior.

I do hereby waive any and all rights that I may have to institute legal proceedings of any kind arising out of my or my pet's usage of the dog park.

I have carefully read this form and been given an opportunity to consult with an attorney regarding same. I fully understand, agree with, and accept its terms and conditions as outlined. I hereby do verify that I am over that age of 18 years and am the owner of the dog (s) listed below.

I understand that all fees paid are non-refundable and that my access card may be revoked by the Village for misuse of the Dog Park or repeated aggression on the park of any one of the dogs under my direct ownership or supervision or violation by either me or my dog (s) of the rules and regulations.

TO ALL DOG OWNERS:

THESE ARE YOUR RULES PLEASE ABIDE BY THEM!

ONLY REGISTERED DOG PARK MEMBERS AND THEIR GUESTS ARE ALLOWED IN THE DOG PARK

RESPECT AND EXTEND PROPER COURTESY TO OTHERS.

1. Small dogs up to 30lbs are allowed in small dog park.
2. Medium to large dogs over 30lbs are only allowed in large dog park. Dog owners of dogs' under 30lbs may use the large dog park if they decide.
3. Close all gates to Dog Park after entering and exiting the park.
4. Corral areas will have an outer and inner entrance gates. First, close the entrance gate behind you. Then remove the leash from your dog. Then open the inner gate and let your dog in and close the inner gate behind you.
5. Keep your dog in sight and under voice control at all times. Owners may not leave the park without their dogs.
6. Clean up and dispose of feces left by your dog both inside and outside the off-leash area. All waste must be disposed of properly in the designated on-site containers.
7. All required dog vaccination shots must be current. All Dogs must be wearing current Dog license, name tag and rabies tags as required by law.
8. Do not bring any chews, food, dog toys, balls, water bowls, etc., into the dog park, as dog fights may result. Small, bite-size training treats are permitted.
9. Users are limited to two dogs per visit.
10. No animals other than dogs are allowed inside the fenced area.
11. Female dogs in heat and dogs under the age of four months are prohibited.
12. Unneutered males must be removed at the first sign of aggression. It is strongly suggested that unneutered males not be brought to the park (neutering reduces aggression in male dogs).
13. No aggressive dogs allowed. If your dog becomes unruly or plays rough, leash it and leave immediately.
14. Stop your dog from digging holes and fill in any holes it has created.
15. No prong, spike or choke collars are permitted.
16. Dogs that have not socialized with other dogs should be brought to the Dog Park during weekdays when park is less crowded.
17. Dogs owners must not allow their dog (s) to jump on other dog owners.
18. Know your dog's behavior.
19. Glass containers, alcohol and food are prohibited in park.
20. Bike riding, skateboarding, rollerblading, scooters, and roller-skating are prohibited within park grounds.
21. The Village reserves the right to remove a dog owner's membership status when owners violate the rules of the park.
22. No Trespassing.
23. USE THE PARK AT YOUR OWN RISK! Owners are responsible and liable for the actions of their Dogs.
24. All other Valley Stream Dog Park rules apply.
25. No Smoking or eating in Dog Park.
26. No pet grooming in the park.
27. Children 12 years of age and older are permitted in the dog parks and must be under adult supervision at all times.
28. Members are allowed to bring Guest(s).
29. The purpose of the dog park is enjoyment for all users, canine and humans. Let's make it so.
